

Overview

The Workers' Compensation Insurance Rating Bureau of California (WCIRB) offers experience rating data in the WCRATING format for all issued and withdrawn California experience rating worksheets (rate sheets). This file will allow you to use the data from a rate sheet in your system. It is not permissible to print and distribute rate sheets from this file. If you would like to print a rate sheet for distribution outside your organization, you may only do so using the Adobe Acrobat PDF file. The WCRATING format is sent via FTP and/or WCIRB Connect. In WCIRB Connect, the data product can be retrieved from the navigation Menu by clicking Reports/Data Products.

This guide will assist you in programming your system for the California WCRATING files and provides a complete list, by record, of each field that may be reported in a California WCRATING file.

Basic File Presentation

The WCRATING file starts with a Header Record (Record 00) and ends with a Trailer Record (Record 99). The Trailer Record gives both the detailed record count and the number of ratings for the complete file. Each rate sheet will have unique link data to separate it from the other rate sheets in the file.

Policy Issuing Offices

The Policy Issuing Office shown on the printed rate sheet (reported in Record 06) is shown as the City Name.

Rerate Effective Date

The Rerate Effective Date is a distinct field on Record B1. Prior to 2012, it was reported as the anniversary rating date (ARD) in the link data. This should prevent confusion regarding changes in the ARD date. If a Rerate Effective Date is reported, it is the actual date the experience modification should be applied rather than the Rating Effective Date.

Message Records

Most message records have an identifying code which assists in identifying the contents of the message. Generic messages (message code 999) only exist for non-critical messages.

Rate Sheet Identification Number

All rate sheets will include the Rate Sheet Identification Number which matches the number printed at the bottom of the rate sheet. This Rate Sheet Identification Number is included in the PDF file name and the XML Rate Sheet Companion File for those who receive rate sheets in the PDF format. For further information about linking rate sheets to their associated data, please refer to the *Companion File for Experience Rating Worksheets* documentation from the WCIRB.
