**Overview**

The Workers' Compensation Insurance Rating Bureau of California (WCIRB) offers a listing of your policies where the USR has not been submitted but is due this month. The delinquent (pending) list data file is sent via FTP and/or WCIRB Connect. In WCIRB Connect, the data product can be retrieved from the navigation Menu by clicking Reports/Data Products.

This guide will outline the format of the assist you in programming your system.

**File Naming Convention**

The format of the file name is MMDDYYYY/XXXXX\_YYMMDD\_USRDELQ\_N

MMDDYYYY – date of report evaluation

XXXXX – Group Code

YYMMDD – date of file creation

N – file number, incremented by 1 for each file created on same date

**Basic File Presentation**

The file starts with a Group Name, Report Generation Date. The next line contains the carrier name.

**Delinquent (Pending) Report Policy List**

The report lists Rated policies grouped by Report Level. Therefore, all the Rated policies are grouped by ascending report level order followed by the Non-Rated policies grouped by ascending report level.

Policy Number, Policy Inception Date and Bureau Number are listed for each policy where USR report level was not received in a timely manner.
